Deposits

- Choose a monthly commitment amount that is right for you
- The minimum deposit to enroll is \$75
- You can deposit more than your monthly commitment, but not less. The minimum monthly requirement is \$20
- If a recurring charge or a mailed check does not clear the bank you are responsible for \$25 Non Sufficient Fund Charge
- If you deplete your account and maintain a \$0 balance for more than 2 months, your account will be closed. You will need to re-enroll to participate in the pre-payment plan again
- If 2 month's deposits are not received you must re-enroll
- After 3 years of no activity, funds will no longer be available for use or refunds

Refunds and Transfers

- A \$50 fee will be assessed for refunds
- Funds can be transferred to another NAFCC activity, such as conference or sales. A \$15 transfer fee will be assessed
