

#### **PROFESSIONAL DEVELOPMENT**

Community outreach is the heartbeat of our professional development department at NAFCC. This year we were intentional about having boots on the ground. We attended 4 conferences across the US, #BCDI in Georgia, #PFCCAG in Georgia, #NBCDI in Charlotte, and #NAEYC in Nashville! To top off our year-long tour, we hosted a 'Meet and Greet' for all FCC educators across the country in Nashville Tennessee!





#### MEMBERSHIP

This year marked immense growth and progress for NAFCC in expanding membership benefits and opportunities for family child care educators. Membership increased by 10% as we launched new partnerships, such as discounted higher education with Walden University and teaching supplies through Lakeshore. We are also growing our staff infrastructure to improve customer service. Next year, we're excited to launch our new affiliate program.

#### **POLICY & ADVOCACY**

The NAFCC policy team & FCC leaders have been on the move ensuring policies are inclusive of homebased child care and the families in their care. We found many ways to center the voices of FCC educators, from hosting 3 highly attended policy webinars in English, Spanish & Mandarin to supporting FCC educators testifying in front of the US Senate, contacting their elected officials and driving actions like the DC Family Child Care Association Walkathon.





#### ACCREDITATION

NAFCC has actively involved over 100 Family Child Care educators, leaders, mentors, and coaches nationwide in becoming certified Accredited Observer and Quality Ambassador Trainers. We take pride in fostering knowledge about our accreditation program, ensuring our newly certified trainers and observers are equipped with tools to champion and uphold Family Child Care Educators' accreditation journeys.
